- **2.** *Lisankhu Pakhar Rural Municipality* invites bids from Nepalese eligible bidders for the **Construction of the works in the table below,** under National Competitive Bidding procedures. Only Eligible bidders with the following key qualification should participate in this bidding.

Minimum work experience: At least 1 (One) number of successful project of Bituminous Premix Carpet (Black Top) works (not necessarily to amount)

- 6. Sealed or electronic bids must be submitted to the office by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Hrs on 2077/06/16. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 2077/06/16 (2nd Oct 2020) at the office of *Lisankhu Pakhar Rural Municipality*, *Attarpur*, *Sindhupalchok*. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2077/09/17 (1st Jan 2021))
- **8.** If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
