6. Sealed or electronic bids must be submitted to the office by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before below mentioned date & time. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend on below mentioned date & Time at the office of **Lisankhu Pakhar Rural Municipality, Attarpur, Sindhupalchok**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2078/01/05 (18th April 2021)**)
